The Bylaws of the **New Orleans Metropolitan Association of REALTORS®, Inc.** direct that no more than three members from each firm may serve at the same time. In addition, in no event shall the number of Category 1 REALTORS® (see Bylaws Article IV, Section 3, a.1.) and REALTORS® who are engaged in the real estate profession in positions of management control on behalf of sole proprietors or corporate officers be less than 50% of the At-Large Directors.
